### ***Declarative Premise with Supporting Facts***

Declarative Directive #1 Regarding the several-nation COVID-19 Government/Sector Vaccine Mandate

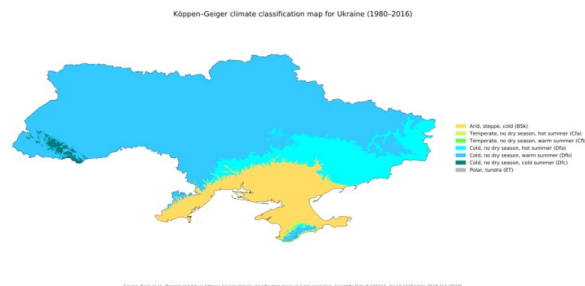
Declarative Directive #3 Regarding the Russian/Ukraine Annexation of 2021 and the Famine in Afghanistan
