#### Declarative Directives 17-18

#### Directive 17

Due to the present fentanyl crisis and other assaultive, murderous and gang-related intrusions from the domestic and foreign born Spaniard and Negro I asked that empowered state and federal executives and any court-appointed master/independent reviewer of monitor reassign prison-, jail- or hospital-based nurses or psychiatrist to non-medical duties. No medical attire such as scrubs should be worn while conducting reassigned job functions.

### Directive 18

No involuntary needle injections are permitted against state or federal prisoners/jailed inmates, state-, federally-funded hospital residents.
