Declarative Directive #8 Miss.Yellen please do not fund the budgets of municipal police; all inmates should be released or transferred to county jail custody with case bound to the State court.

Premise H.:

As was described in the forgoing, the Department of Defense are seeking to disempower me. Since June 1, 2007 Mr. Spence has suffered many, many incidents of property damage and flesh intrusions. Indeed a timely administrative remedy attempt to the DOD was met with an almost blank form letter reply. Miss.Yellen please do not fund the budgets of municipal police; at this time due to a stalled application for housing at Georgia State and TRANSIENT student status to Keller Graduate School of DeVry all inmates, displaying Personal Self-Defense instead of Paranoid Personal-Defense should be released or transferred to county jail custody with case bound to the State court. Kindly distribute \$3,000 to \$10,000 to each inmate and instruct him or her to return to there state capitol. The Baptist Church nearest Federal State or Municipal facilities must assist its members, breaking the fence to the facility.

i. On Sunday, May 1, 2022 a female officer McCrumar/McShumar slapped my hand and knocked a banana from Mr. Spence's hand. Afterwards Mr. Spence was taken to the Atlanta jail then to Grady Hospital, put into four-point, restraints there a male staffer, with closed fist, moved Mr. Spence's head to the left. I arrived in the city of Atlanta April 1, 2022 in order to file a document against Food Lion with the Equal Opportunity Commission. The office had closed early at 3:00 pm therefore the multi-page cover aff. and letters were stuffed through the glass door and wall.

ii. To cure this homelessness Food Lion must release \$20,000 in severance pay and send a final Separation Notice to the State of Georgia and to PO BOX 829 Atlanta , Georgia 30301 (Three females in the Food Lion home office refused to mail to Separation Notice). Mr. Ken Thomas of Food Lion, a 400 year-old brown Native American and Shemond (DontMove) of Waffle House and suspected Native America used verbal attacks to prevent long-term employment will result in monetary damages. The Department of Agriculture must receive 100% of bank deposits, VISA/MasterCard/Discover Card and check tender should Food Lion to reply to jspence@81Blackmen.org by Thursday, June 22, 2022.

iii. Georgia State must allow housing to be provided for at the Georgia State University lofts. Dr. Mark Beck please reply by email AND letter to PO Box 829 Atlanta, GA 30301. Someone has jammed key access to the box, however a postal work did give the parcels over the counter.

Declarative Directive #9 The Department of Homeland Security must deny all pending VISA applications and retroactively retroactively deny all VISA and Naturalized Citizens since October 1971.
