#### **Abstract / Overview**

***Whereas Mr. Jeremiah E. Spence*** was wrongfully sentenced on February 16, 2022 to 25 years in prison in a virtual hearing transmitted via webex.com tele- and video conference having room number 290882867, and two motions Mr. Jermaine E. Spence had filed were disregarded at trial:

**1.) With respect to the conviction of Jeremiah in Case Number SUR 2019 0000 285 it shall be the declaration of this Summary Criminal Complaint Case #2022-cr-2 before the Holy Triumvirate that Jeremiah is : NOT Guilty of Count 1 Aggravated Assault; Count 2 Terroristic Threats; Count 3 Obstruction . In the interim Mr. Jermaine Spence seeks an urgent Presidential Pardon by President Mr. Joseph Biden Pardon while an appeal is assembled for REVERSAL of the November 2, 2021 jury conviction.**

**2.) With regard to the aforementioned DEFENDANTS of** Victoria M. Johnson, Gregory W. Edwards, Harold R. Moroz, Kevin Sproul, Gary Dorminy, who are all drug prospective February 20, 2022 Order #4 of the Holy Triumvirate, stipulates that each of the DEFENDANTS receive a 35 years sentence for the charge, Inter Alia, of Conspiracy to Commit Murder to be serve within the Hellenic Republic. #### **Statutory Jurisdiction**

**I, Jermaine E. Spence, have made this Summary Criminal Complaint in International Jurisdiction rather than to the State of Georgia or to the Federal court system of America.**

The Bible of Our Homosexual Brethren reads at Luke 12:58:

"When thou goest with thine adversary to the magistrate, as thou art in the way, give diligence that thou mayest be delivered from him; lest he hale thee to the judge, and the judge deliver thee to the officer, and the officer case thee into prison."

The court system corrupt operations must be halted.

With respect to bravery my Brothers and Sisters The Holy Bible gives hope and God's Good Homosexuals must believe in The Canons of the Homosexual Catholic Church that are the oldest laws in the world. Surely these acts of Racketeering, Conspiracy to commit murder, False Imprisonment and False Writings enumerated herein, having been outlawed for eons, deserve a response from an international crime fighting body.

Furthermore the United Nations who will receive a hard photocopy of this complaint must see that the all five Defendants have engaged in Ethnic Cleansing in order to rid the cities and states of the United States of America of persons who are not proponents of the legalization of marijuana.

In closing please know that Jermaine E. Spence has cited state and Federal criminal codes in order to charge the defendants.

**Criminal Complaint**

Case A - In the Matter of Victoria M. Johnson

Count 1: OCGA 16-14-4 Racketeer Influenced and Corrupt Organizations - Prohibited Activities / 18 USC sec. 1962. Johnson, as assistant magistrate judge of Dougherty County, refused in July 2021 to allow Mr. Spence to file his Criminal Warrant Application and pay the applicable filing fees allowed by OCGA 15-10-2, 15-10-82 and 17-4-40. Johnson repeatedly asked during a meeting with Jermaine while reviewing the application why the criminal complaint did not contain the name of Mike Gravette who was Jermaine's rent collector that has suspected ties to the Klu Klux Klan of Alabama. Had Jermaine included Gravette in the complaint before the magistrate court then Gravette, who over a 18-month period had forced in the absence of a probate court hearing Jermaine's admission to a mental health clinic for nine months, had intercepted Jermaine's timely rent payments and had caused 8 to 9 months of lost employment. Johnson's and Gravette's behavior came along with 14 years of misconduct starting in June 2007 when a trashy women and her Jew/KKK male companion rammed Mr. Spence's park car; this would be the first of 4 parked or low velocity intentional car accidents and was proceeded by at least two intentional automobile collisions against Jermaine and Jeremiah's mother Ms. Delphine Lingo. In November 2007 a female ward janitor/nurse's assistant at Grady Hospital Atlanta did inject Jermaine with a sedative that caused more than 24 hours of sleep. Afterwards Jermaine spent more than 8 years behind bars before Fulton County DISMISSED the charges. Jermaine was severely beaten by Charles Sheppard on Christmas Day 2010. Johnson has no intentions of operating a legally sound magistrate court. **Recommended Sentence: 5 years**

Count 2: OCGA 16-4-2 Conviction for criminal attempt where crime completed / 18 USC 1117 Conspiracy to Murder. Johnson has positioned herself in Dougherty county in order to further the agenda of the drug cartel gangs. Therefore she has sought to eliminate by way of murderous Death any persons whose vote opposes that of the drug producing, distributing, trafficking cartels.

**Recommended Sentence: 35 years**

**Criminal Complaint**

Case B - In the Matter of Gregory W. Edwards

Count 1: OCGA 16-14-4 Racketeer Influenced and Corrupt Organizations - Prohibited Activities / 18 USC sec. 1962. Edwards is a part of a drug cartel cell association who prosecuted Jeremiah after coercing Nicolas Odom to harass Jeremiah on the day of the incidents in question. In fact Jermaine, before and after his return to Albany, Georgia after a 20-year hiatus, has had many encounters with drug users, gangs and persons who desire the legalization of marijuana. Edwards impaneled a jury that were most likely not an accurate representation of Jeremiah's peers. Jeremiah is not a drug abuser, earned a Master's degree and has had relations with Men, therefore the Voir Dire processes did not exclude jurors who were former or present drug users, were without collegiate study or master's degree and who were Homophobic. (Jermaine is an examined Genius Homosexual who excelled academically and who did complete and score successfully on an Intelligent Quotient examination.) **Recommended Sentence: 5 years**

Count 2: OCGA 16-4-2 Conviction for criminal attempt where crime completed. Edwards would not release the names and addresses of the Dougherty County grand jury so that Jermaine could make a Special Presentment. With regard to the plot against Jeremiah Edwards conspires against the wholesomeness of Albany and the State of Georgia and will cause the downfall of society

if farm resources are reallocated for wasteful uses such as for the cultivation of marijuana. Although Federal Code contains a marijuana prohibition at 21 USC 863 several states have gone on their own to legalize marijuana and marijuana derivatives.

**Recommended Sentence: 35 years**

#### **Criminal Complaint**

Case C - In the Matter of Harold R. Moroz

Count 1: OCGA 16-4-2 Conviction for criminal attempt where crime completed: Moroz is a part of a Latino drug cartel ring who has preyed upon the Spence family for many years. In the Summer of 2002 after Jermaine's and Jeremiah's father was arrested and held for driving under the influence two Spaniards meandered of the city boulevard and encountered Mr. Spence after Mr. Spence had passed a neighbor stop sign on Clark Avenue. The Spanish witch yelled at Mr. Spence and wrote a citation for the smoking tail pipe and broken shattered windshield that would eventually total more than \$700 in fines. The Terroristic threat code at OCGA 16-11-37 is criminally constructed such that no bystander, non-victim witness is necessary to make a corroborated statement in order to substantiate the charge. Moroz and the drug cell are destructively altering Federal and State law to have Marijuana use legalized.

#### **Criminal Complaint**

Case D - In the Matter of Kevin Sproul

Count 1: OCGA 16-5-42 False imprisonment under color of legal process: Sproul, sheriff of Dougherty County, has held Jeremiah and thousands of African-American, Caucasian and Latino men and women in a unlawful manner by denying them access to 8.5"x11" for the entire duration of their detention at the Dougherty County Jail facility. Instead inmates are given small, paper leaflets. Jermaine wrote directly to the sheriff whose subordinate refused to modify the oppressive rule that has worked to prevent Jeremiah from entering an adequate legal defense.

The statute at 16-5-42 reads:

"When the arrest, confinement, or detention of a person by warrant, mandate, or process is manifestly illegal and shows malice and oppression, an officer issuing or knowingly and maliciously executing the same shall, upon conviction thereof, be removed from office and punished by imprisonment for not less than one nor more than ten years."

Count 2: OCGA 16-4-2 Conviction for criminal attempt where crime completed: Sproul's rule system gives tacit support to the Latino drug cartels that have persecuted Brother Jeremiah because it has subjected Jeremiah to a system of rampant First, Fifth and Fourteenth Amendment and the resulting conviction and 25-year sentence. **Recommended Sentence: 35 years**

#### **Criminal Complaint**

Case E - In the Matter of Gary Dorminy

Count 1: OCGA 16-10-20 False Statements and writings, concealment of facts, and fraudulent documents in matters within of state or political subdivisions: Dorminy falsely charged Jeremiah with Aggravated Assault and Terroristic Threat against Nicolas Odom and Obstruction of Officer William M. Kornegay. Indeed Dorminy never reported that Jeremiah physically struck Odom and there was no sworn witness statement contained in the 113 pages on the record at the time Jermaine viewed the docket. Furthermore Jeremiah did comply with the orders of Kornegay as it is apparent that Jeremiah was arrested without struggle. It should also be noted that Jeremiah did wonderfully while on bond, residing at a gated apartment complex in downtown Albany. Jeremiah had complained to Jermaine that his neighbors at the former residence were horrendous. **Recommended Sentence: 5 years**

Count 2: OCGA 16-4-2 Conviction for criminal attempt where crime completed: Detective Dorminy created a false writing in order to have Jeremiah convicted of crime and to be subjected to incarceration where Jeremiah would be at risk of abuse by jail and prison inmates while detained. This incarceration could result in the Death of Jeremiah. **Recommended Sentence: 35 years**
