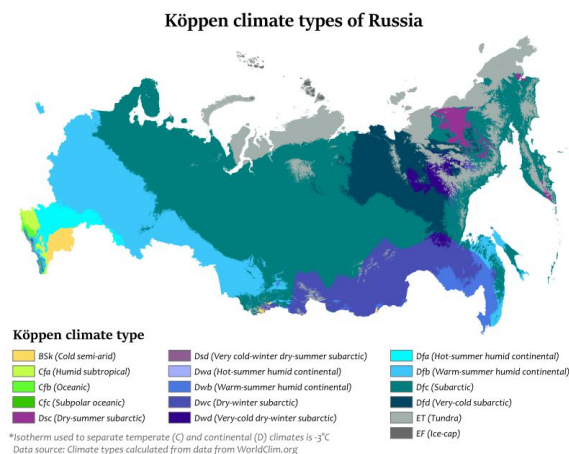

Mr. Biden:

I have recomposed the following initiatives that I hope your administration will implement, and special thanks to fm. First Lady Michelle Obama for reminding of us all of the notion of the White House initiative.

Also please know that I eagerly await the 2020 grant request of \$4,000, which should be preceded by a telephone call to 912 675 3817.

Initiative 1 - White House Rebuilt! - construct an all steel, nuclear-ready fortified White House.

Initiative 2 - Lost Parcel Service - to encourage commerce and spur profits, please direct the United States Postal Service to devise a feasible solution to lost and misdirected mail and packages. Presently several parcels are being returned to sender, including to myself and another federal office with which I regularly communicate. See attached letter dated April 26, 2021.

[REVISED] Initiative 3 - Pensions for USA - Private sector corporations must receive funding by way of investment brokers in order to offer federally-insured pensions. The expanded health care benefit must not be the extent of federal legislation with regard to individual financial products. If this can not be implemented, in lieu of all private corporations providing pensions it is my hope that the SSI pays a minimum of \$2,000 monthly.

Initiative 4 - FDIC expanded - The FDIC must operate a physical office in one to five cities in each state to facilitate claims in the event of bank failure.

Initiative 5 - No Death Penalty - Mr. Biden please place a moratorium on the death penalty until an executive branch agency is able to provide added oversight to failures in Due Process.

[REVISED] Initiative 6 - 80% reduction in table sugar (sucrose) in American goods [breakfast cereals, artificial juices and candies].

[RETRACTED] Initiative 7 - No Area 51.

Initiative 8 - Tax Credits for the Sole Proprietor - Currently no EIC is allowed for self-employment activity as IRS Schedule C for Form 1040 does not allow credits of any sort.

Initiative 9 - Recycle All Refuse - paper, plastics, styrofoam and metal

Initiative 10 - FEMA must create a military/police/gang duress program.

Initiative 10i - civil action remedy involving military or police activity resulting in assault, dismemberment or death of a civilian or enlisted person shall carry a 15-year statute of limitations and 25-year statute of limitations for violent activity against one who is detained/incarcerated.

Initiative 10ii - With reliance on an amended war crimes statute at 18 USC 2441 US prosecutors shall have the ability to appeal an acquittal should the defendants be military or police laymen.

Initiative 10iii - The Dept. of Defense must disclose all names of active duty personnel to the public upon request.

[REVISED] Initiative 10iv - County and municipal police maintain a registry of all employed law enforcement, listing name and a physical address for service of process.

Initiative 11 - Federal Teacher's Guilds must be chartered and funded to compensate schools systems with no pupils. Teacher's Guilds will allow instructors who have achieved a Bachelor's degree or more to re-enter their former school house and earn a reduced income while engaging in solitary reading of their chosen lexicon and completing all the subjects activities thus preserving multiple disciplines, the tax base, the buildings and fostering community involvement and guidance to our nation's youngsters.

Initiative 12 - This administration must reduce [actively monitor] private sector acquisition of the materials utilize in nuclear devices.

Initiative/Doctrine 13 - Kindly order that military personnel deployed to the Middle East secure oil, gas, coal fields and plants etc. instead of meandering through the cities. The troops should be no more than 1 mile away from the each plant.

Initiative 14 - No public or private building should have two unsafe exterior handles on exit/entrance doors. This presents perils because the door could be chained shut from the outside, preventing the building's occupants from exiting.

Initiative 15 - Student loan lifetime maximum of \$200,000.

Initiative 16 - Mr. Biden please initiate a Federal effort to inspect all U.S. based federal, state and private mental health hospitals and wards for instances of undue detention and murder of their patients. Social Security tax records should be utilized in order to ascertain the names of employees who may have brought undue detain of the supposed mentally ill.

Initiative 16i - The State of Georgia's Central State Hospital involvement in the deadly Eugenics movement should be explored as it is my belief that formaldehyde was lethally administered to the unduly detained.

Initiative 16ii - Grady Memorial Hospital should undergo a similar exploration into its Eugenics movement involvement.

Initiative 44 - May there be a temporary federal ban on involuntary admissions to Adult Mental Health wards of private, state and federal facilities

Initiative 17 was mistakenly numbered as Initiative 16. Therefore the correction adjusts all subsequent initiatives by an increase of 1 digit.

Initiative 17 - There must be no medical or recreational marijuana use in the United States.

Initiative 18 - Mr. Turmp please remain 12 years as President.

Initiative 19 - Megalopolis such as New York City, Atlanta, Boston, Houston, Los Angeles etc. should engage in the greenhouse farming of vine-originating crops such as Tomatoes and Grapes. Such activity may encourage conservative attitudes regarding health & wellness, may reduce crime and add employment and technical know-how and bring a greater Psychological well-being all while curbing addictions.

Initiative 20 - Stop Bank Escheatment ! Kindly, no bank should be allowed to transfer to state custody dormant accounts; alternatively banks should carry out temporary account suspensions to prevent balance depletion due to the monthly fee.

[RETRACTED] Initiative 20i - to 20ii - During this COVID-19 and Coronavirus disease crisis no bank account should be closed due to dormancy or a zero balance.

Initiative 21 - Nuclear powered automobiles must be outlawed.

Initiative 22 - In light of the Federal debt no licensed banker's Federal Reserve account should be totally exhausted at any point. Therefore banks themselves must make a partial deposit of their profits and capital cashflows into one separate Federal Reserve account than their consumer's Federal Reserve balances. In the case of mass withdrawals or calamity the bank therefore will have funds to pay its salaried/commission-based employees--some who are licensed-- and be able to borrow from the treasury to weather a national hardship.

Initiative 23 - The skin of vegetables such as potatoes, potato flakes, many other vegetables like carrots and canned fruits should be left unpeeled.

Initiative 24 - With respect to the immigration crisis, farmers needing labor must receive grants and/or low-interest loans to purchase conveyor belts that can be placed near rows of vegetable- and fruit-producing trees such as corn, apple, wheat and the likes, assisting with the harvesting process in getting the crop transported to the markets and alleviating labor shortages.

Initiative 25 - No nuclear power companies in any of the 50 United States, kindly.

Initiative 26 - A Federal or State exonerated prisoner or discharged hospital detainee shall immediately receive \$3,000 dollars. One who is acquitted of municipal charges must receive \$1,500.

On February 23, 2008 my 1996 Lexus LS was totaled beyond repair in a collision involving Mr. Teal's vehicle. A citation was written naming me as a defendant in The State of Georgia vs Jermaine E. Spence accusation of Impeding Traffic Flow. Although I stated both in print and verbally that I was not at fault, Mr. Teal's insurance carrier refused to award damages in my favor, won an arbitration hearing in his favor and demanded that my carrier Geico (Claim Number 0242775710101036) make payments to recover Mr. Teal's losses. Since that January 2009 arbitration hearing, I was able to obtain a court order from the State Court of Rockdale County that closed the case and cleared me of any wrong doing, including any liability for damaging Mr. Teal's automobile. Dear Ms. Michini:

I am in receipt of the latest results of negotiations regarding the above-referenced accident which occurred in Rockdale County, Georgia. The attached determination letter from GEICO is dated January 16, 2009.

I have indicated verbally and in hard copy print in letters dated September 15, 2007 and October 19, 2008 sent to GEICO and State Farm that I am not at fault in the accident, and that the police report (SEE Georgia Uniform Motor Vehicle Accident Report) erroneously indicated that my vehicle was parked on the left lane of the road at the time of the accident. The car was parked on the right shoulder of the road at the time of the accident, although its whereabouts after the collision are not important when considering the cause of the accident.

The January 16, 2009 GEICO letter states that the arbitration committee decided in the favor of Mr. Teal and State Farm. As was the basis for the foregoing decisions for both GEICO and State Farm, the results of the arbitration panel were based on the accident report prepared by Rockdale County Deputy J. Peek

Since that time, Rockdale County in The State Court v. Jermaine E. Spence (defendant) ruled on the accident and Mr. Teal's official statements. On October 15, 2009 the State Court ruled Nolle Prosequi which is equivalent to 'Not Guilty' or 'Case Dismissed'. (SEE State Court order)

The evidence presented, including Deputy Peek's pencil-like accident report, the absence of photographs, my testimony and that of Mr. Teal's, were not sufficient for a guilty ruling, and therefore, once again, I am not at fault in the February 23 accident. My photographs which are attached show that the LEFT REAR area of my vehicle displayed more severe damage than the RIGHT REAR portion. The LEFT REAR region of my vehicle was nearest the highway and oncoming traffic and sustained the burden of the collision with Mr. Teal's vehicle. Additionally for your review I have attached the laboratory result (Grady Memorial Hospital) displaying a blood/alcohol level which is within legal limits for the State of Georgia..

Under the clauses of my GEICO contract I am writing to request that all amounts paid by me and GEICO be refunded accordingly. Include in the GEICO calculations are those amounts made as a settlement and paid to both Mr. Teal and State Farm.

Georgia law Title 33-24-56.1 states that the amounts recovered which were paid under Mr. Teal's vehicle insurance medical damages provisions must be returned to GEICO. However, GEICO did not pay to me any amounts for medical expenses because the bodily injury rider was not present on the GEICO contract at the time of the accident. Please make payment promptly to Dr. Charles Bell for medical costs as is detailed in Exhibit Diagram A.

In addition as is mandated by Georgia law title 10-7-47 and by the Subrogation provision in the GEICO insurance contract I am personally allowed to pursue property damages for GEICO's principal sum paid to the loan holder Bank of America, as a personal remedy by way of the comprehensive coverage laid forth in the GEICO contract, as well as recover the amounts paid to Mr. Teel and State Farm.

The most important figures which are due are underlined and represent the amounts which would indemnify both me and GEICO.

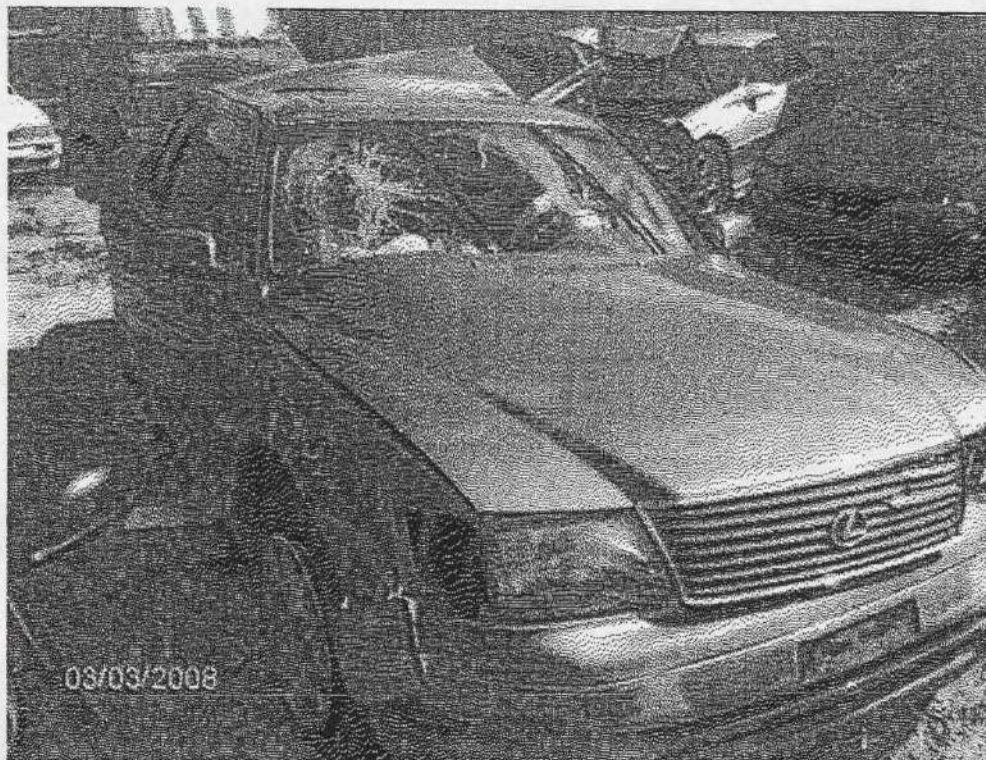

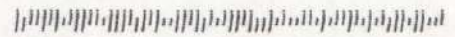

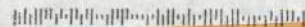

With regard to civil action before the United States Supreme Court Mr. Spence is empowered to bring about litigation against Goldman Sachs Group, Inc., present and ongoing fiduciary for the KKK, New York Life Insurance Company, present and ongoing fiduciary for the KKK, Ms. Nanzi Quesi (pronounced We So), founder of the NAZI party on Earth and The United States of America – Central Intelligence Agency (US-CIA) by way of 28 U.S.C. 1331; *this a H. also refers on 28 U.S.C. 1331 with regard to Stat Fom.*

With regard to civil action before the United States Supreme Court Mr. Spence is empowered to bring about litigation against Mr. Arnold A. Schwarzenegger, former Governor of the State of California and member of NAZI party by way of 28 U.S.C. 1331;

With regard to civil action before the United States Supreme Court Mr. Spence is empowered to bring about litigation against The Office of the President by way of 28 U.S.C. 1651(a);

III. The Cases

- A. In Regards to The United States of America – Department of Defense (US-DOD) thru Mrs. Elizabeth Correnti, MD and three John Does (In Their Official Capacity)
- B. Mrs. Elizabeth Correnti, MD (In Her Individual Capacity)
- i. Wrongdoing Demonstrated: With the keen intelligence and manpower backing of the US-DOD Correnti deprived Mr. Spence of the U.S. Constitutional right of the Due Process Guarantee that consists of Life, Liberty and Property that is found in the Fifth and Fourteenth Amendments. Specifically the unfounded tortious kidnapping and liberty- and income-depriving detention of Mr. Spence's African-American and Homosexual person by Correnti lasted from March 2019 until July 2020. On April 9, 2019 Correnti, who had agreed on March 26 to allow Mr. Spence to 'skip' the daily tablet with no Pro Rata Nota (PRN) injection, ordered a powerful narcotic PRN that resulted in two hours of Mr. Spence sleeping outside of the unit 6 building for more than two hours and is Case C of 1:19-cv-5722 before the 11th Circuit. (All Individuals on the unit were directed to exit the building to engage in the daily activities on the lawn)
 - ii. Historical Background: Mr. Spence had no criminal history or pending criminal matter at the time of initial contact with Correnti and should have been permitted immediate discharge or enrollment in the federally mandated off-campus work program. Mr. Spence had a lengthy conversation with Correnti on March 26, informing Correnti of intentions to become an elected official such as President, Governor or Mayor. Mr. Spence gave a detailed explanation regarding the Dist. Atty. of Fulton County who removed an April 2010 indictment in December 2018 and did not remove a secret May 2014 pre-indictment that led to joblessness once Mr. Spence had departed 8 years and 8 months of incarceration. (Case B of 5722 sues the Dist. Atty's office, former DA Paul Howard and a female assistant.) Correnti's treatment of Mr. Spence was demonic. Correnti often smiled to ingratiate herself with Mr. Spence in order that Mr. Spence's display of humor or a revelation of personal anecdotes pertaining to Religion or Politics would give rise to increased drug in the regimen. And Scott Cooper of Morgan Stanley, formerly of the US-DOD, refused to provide written employment invitation.
 - iii. Law Review: Bivens is a case that involves several federal actors violating the Constitutional rights of another. Because OCGA 37-3-81, 81.1 and 83 mandated that all who reach the Involuntary Treatment or Continued Involuntary Treatment must be both mentally ill and violent and/or with poor self-care the detention between March 25, 2019 and July 2020 was Liberty- and Property-depriving Kidnapping. Even more section 83(c) mandates that quorum be met before Correnti's panel concerning continx. Involx. Trtx beyond October 2019 be presented to a State of Georgia admin. law judge; quorum was not met in September 2019 as the panel, consisting of angry lying females, lacked 1 of three physicians. One female had on an earlier occasion entered a note in the medical record that Mr. Spence physically attempted to harm his own mother.
 - iv. Administrative Remedy Sought: Mr. Spence seeks \$50,000 in compensatory damages from Correnti and \$1,000,000 in punitive damages from the US-DOD.

- C. The Klu Klux Klan (KKK) of the State of Arkansas, Alabama thru Mr. Michael "Mike" Gravette-a rent collector at an Albany, Georgia housing provider
- D. Goldman Sachs Group, Inc., present and ongoing fiduciary for the KKK
- E. New York Life Insurance Company, present and ongoing fiduciary for the KKK
- F. The Nation of Israel

- i. Wrongdoing Demonstrated: Somehow the Jewish-created KKK knows Mr. Spence's exact whereabouts—this is a tort of Eavesdropping. After leaving Columbus, Georgia and the interaction with Correnti in July 2020 Mr. Spence returned to his hometown of Albany, Georgia. (Mr. Spence lived in Atlanta, Georgia from August 2002 to May 2014, attending and graduating college at Georgia State University with a degree in Psychology; Mr. Spence had attempted a second bachelor's in Journalism.) Mr. Spence presented the matter to all four store managers before completing a web form August 26, 2021 sent to the home office. Israel, the Nation of Poland and Jews domestically and abroad are now hitting America.

- ii. Historical Background: On June 1, 2007 a male Cyclops-eyed Jew/Caucasian blend and a female driver rammed Mr. Spence's parked Nissan Maxima, causing \$400 of damages; there would be by May 2008 three additional parked- or low-velocity accidents. 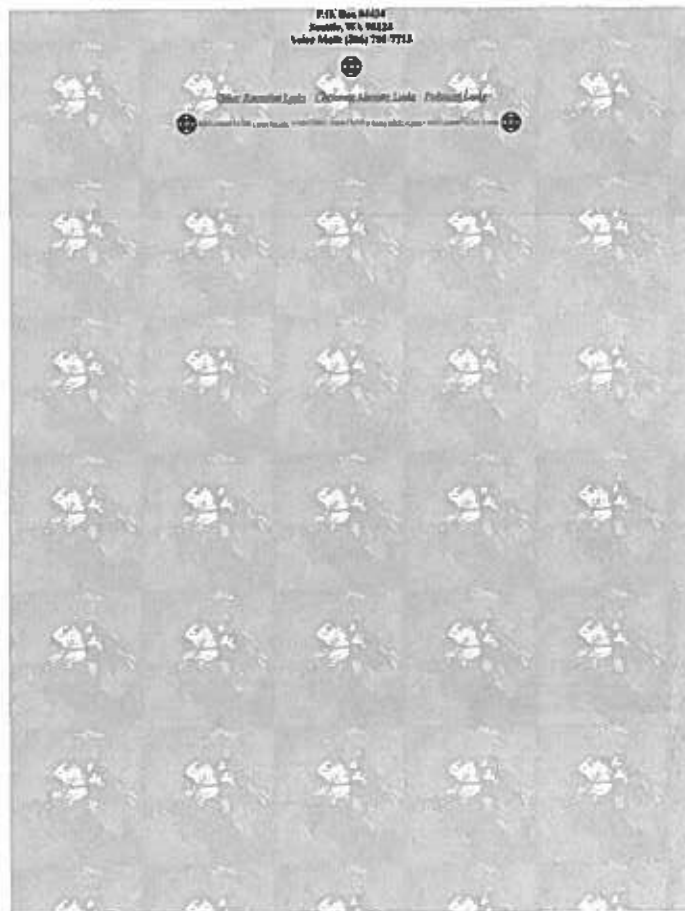

G. Ms. Nanzi Quesi (pronounced We So), founder of the NAZI party on Earth

H. Mr. Arnold A. Schwarzenegger, former Governor of the State of California and member of NAZI party

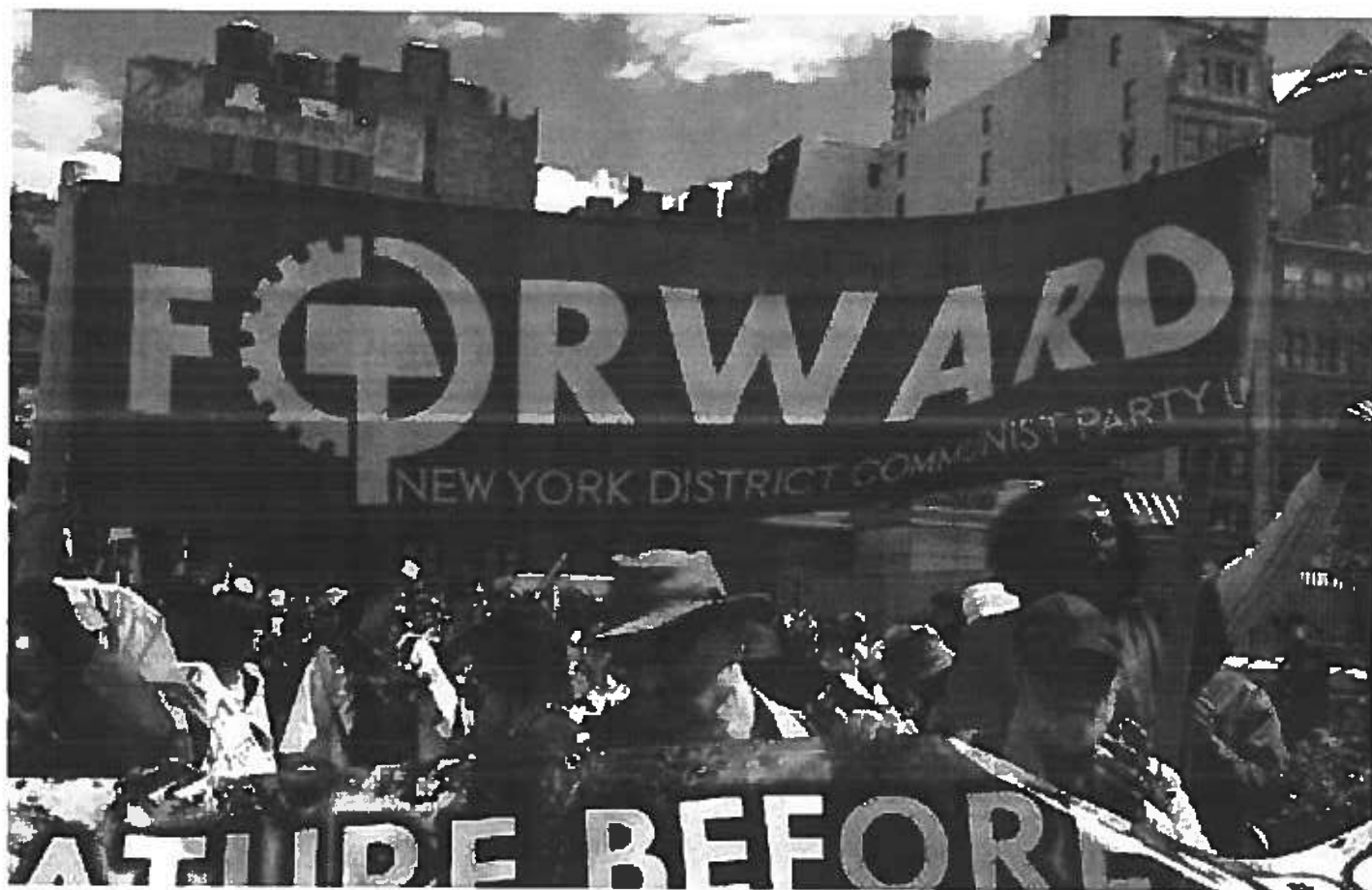

- Shortly thereafter Biden made public his intentions to fruitlessly inject 60 million or people involuntarily in response to the COVID respiratory illness.

J. The United States of America - Central Intelligence Agency (US-CIA)
