



Abstract / Overview

Whereas as of January 2022 the Russian Federation has made a military buildup near the borders of Ukraine, seemingly to invade and occupy Ukraine, Mr. Spence opposes invasion of, war with and the occupation of Ukraine by Russia. Russia must withdraw ground troops from nearby Ukrainian lands; any nuclear material inside of Ukraine will be to their destruction.
