Dear Mr. Trump:

I offer my apology for the timing of these messages in this your fifth month of presidency. I intended to write earlier, however I was prevented from doing so while in non-forensic State of Georgia. This communication was partially submitted to webform at [WhiteHouse.gov](https://www.whitehouse.gov) and by email to communications@mail.whitehouse.gov. The \$4,000* grant request of FreedomTree Asset Management is outstanding.

(A)(i)

In a non-partisan manner and as founder of the Fair Capitalist Party EIN XX-XXX3195 first please let us discuss Initiative 61(i) (SEE Footnote 1) and the matter of inflated retail prices and residential rent levels. The Inflation Crisis of 2025 that has now arisen after the COVID-19 epidemic must be addressed. Kindly utilize powers by way of an Executive Order and the jurisdiction found in the various martial law statutes (SEE Footnote 2) to reduce ALL retail prices by a factor of 5%. This of course is multiplying the shelf price by the decimal .95. Wholesalers will continue to sell their goods to stores, but there will be a demand for both parties—wholesales and their purchasers such as stores and online retailers—to enter into negotiations to lower prices. The U.S. Department of Commerce should then be tasked to secret shop store shelves and virtual marketplaces and (i) Collect a List of Staples, (ii) make Research of Consumer Sentiments (iii) make a monthly Report to the White House and (iv) recommend a 10% Internal Revenue Service non compliance fine/penalty assessment against before dividend corporate c-corp and LLC Revenue. This is the figure before dividend-adjusted Income and before after tax Net Income should their items not undergo these price reductions. Sole proprietors, partnerships and limited partnerships and trusts shall be exempt. The term of this Executive Order should be two years, which would allow the United States Congress ample time to conduct hearings, to gather internal managerial records and to author and ratify legislation to set prices to their 2019 levels, kindly

The aforementioned list of staples at Federally-enforced price:

- Ream of paper (\$2.50 per ream of 8.5" x 11" and \$3.50 per ream of 8.5" X 14");
- Dry Roasted Unsalted Peanuts \$2.99/lb ; other varieties indexed at an rate of .05%; increased over \$2.99 per pound based on Cost of Goods (i.e. Direct Materials, OH and Direct Labor) . A variety that costs more to produce such as Honey Roasted shall be priced at the respective .05% increment higher in a list of all varieties;

- Chicken Leg Quarters \$.50 cents per pound, a 36.7% decrease from .79 cents;
- Whole Chicken \$1.99 per pound;
- Strawberries in lieu of Bananas (SEE Footnote 3) at \$2.50 per, an 11.6 percent decrease from \$2.70;
- Red Apples \$1.99 per pound;
- Seeded Red, Green and Black Grapes \$1.99 per pound;
- Raisins (store brands) \$2.99;
- White Bread (store brands) \$1.35 per 21 slice loaf; Wheat Bread \$1.25 per 21 slice loaf
- Apple Juice (store brands) \$1.50/64 fl oz.
- Orange Juice (store brands) \$2.99/gallon
- The American Russet White Potato in lieu of Rice at \$95/pound

(A)(ii)

As far as residential rent levels, I began communications with the Fulton County Board of Commissioners (Atlanta, Georgia) and later the Dougherty County Board of Commissioners (Albany, Georgia) to have a local ordinance be put into place to limit rent to \$1900 dollars monthly. With hopes that this Initiative 61(ii) of now more than 60 will encourage state-level legislation to mandate Secretary of State dissolution of corporations and limited liabilities companies who are in noncompliance which would result in the collection of Social Security and Medicare/Medicaid tax revenue when corporate proceeds are received in self-employment form. Interestingly Medicare and Medicaid taxes are limitless. 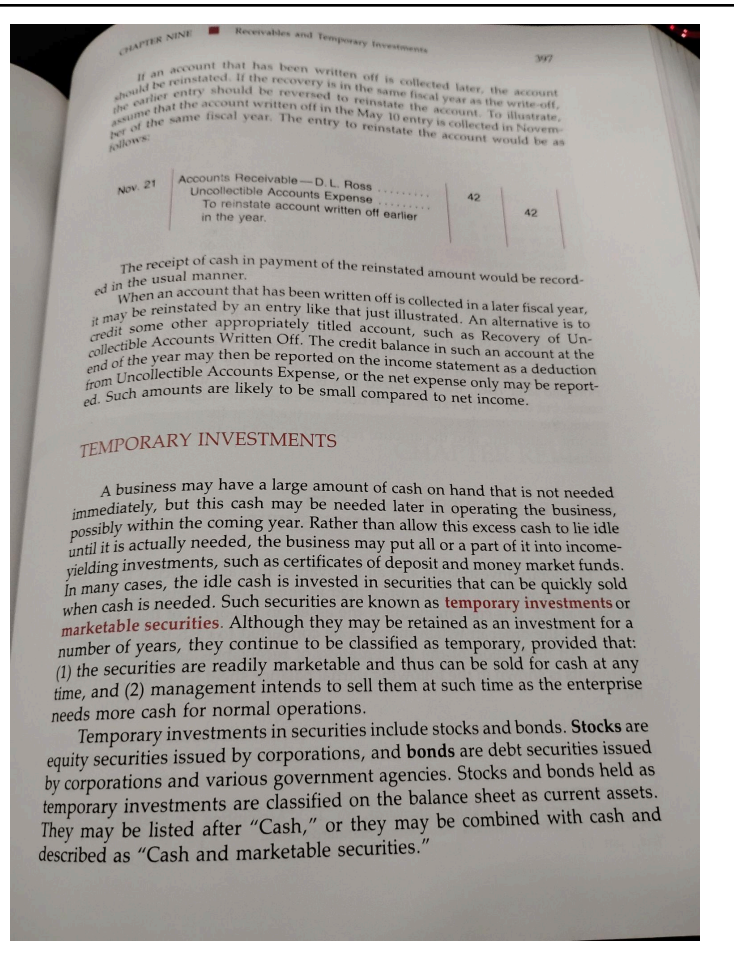
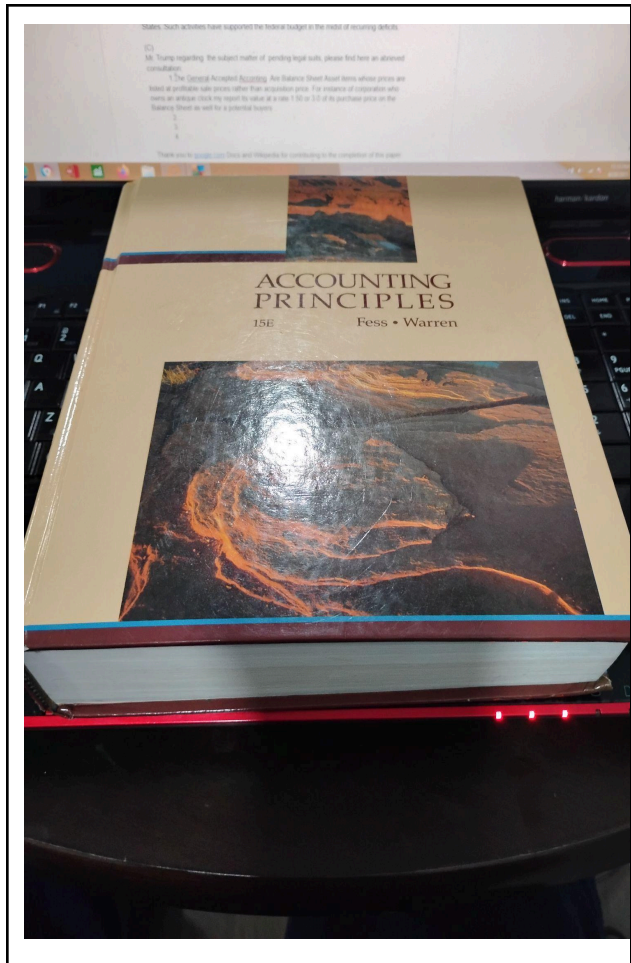

Mr. Trump regarding the subject-matter one of many legal suits and appeals, please find here a brief consultation:

New York v. The Trump Organization: The Generally Accepted Accounting Principle of **Marketable Securities** apply here. This includes not only Stocks and Bonds but other Balance Sheet Asset items whose prices are listed at profitable, adjustable sale prices rather than acquisition price. For instance a corporation that owns an antique clock may report its value at a rate 1.01... 1.50... or 3.0... or more higher than its purchase price on the Balance Sheet for potential buyers. The Trump Organization's accountant Allen Weisselberg and former controller Jeffrey McConney are not guilty. Mr. Trump ratify the Rome Statute of the International Criminal Court and have Attorney General Letitia James Criminally Prosecuted for Destruction and Appropriation of property; have the budget of the respective judicial body reduced and \$345.8 refunded from the purse as this was a War Crime. The court is defined as a court of last resort. In Georgia individuals are permitted to bring criminal actions against others, beginning in Magistrate court. Mr. Trump:

I will be calling to the White House on tomorrow morning in order to follow-up on the October 2020  
\$4,000 grant request of FreedomTree Mutual Funds and Asset Management (See footnote 1). The grant was  
requested because I provided 60 and more Initiatives or what can be described as ideas to the White  
House in order that it draw up legislation. I enjoy being a think tank!

One such idea presented a solution to the recurring budget and cash shortage. This idea proposed that  
mortgage brokers reduce their 'away bank' budget. This is when a mortgage or credit line holder  
(i.e. credit card) draws down a new loan to pay off a higher interest loan. The Federal Reserve lends  
automatically, with in the blink of an eye, to licensed mortgage brokers/bankers at the Discount Rate

which is usually around 1 percent divided by 4 (i.e. .25%) Banks lend to Corporations with good credit at Prime--usually 5%, to each other at the average Fed Funds rate---perhaps .50%(i.e. 50 base points [bps]). The Federal Reserve had borrowed from the public and other nations, and this creates the Federal Debt. The Federal Reserve issues Bills, Notes and Bonds. Bonds return the principal to their owners in 30 years, notes 1 to 10 years and Bills in less than 12 months. The interest rate on the Bond was 4 to 5 percent in certain years before the budget shortage presented a growing insolvency risk for America. Conversely in my belief General Securities stock brokers, Investment Company mutual fund brokers and Investment Advisers currently struggle to have such knee jerk reaction to their funding requests for the activation of fresh grants to be Finance IPO(s), which a IPO company may never need to borrow or issue shares again in their profitable life. These brokers do not seek loans and are not Mortgage Brokers/Banks/Bankers and are examined by a different set of federal exams. BD/IA must be associated with at least 1 of the 446 people who manage the United States Federal government--this is 435 in Congress, 1 to 2 counting the President and Vice President and 9 Supreme Court Justices and Associate Justices who should expect a haircut or percent of the funds BD/IA

Well back to my point: A bank acquiring a refinanced loan should pull the cash off of their corporate balance sheet to pay off the original bank instead of borrowing a new loan at the Federal Reserve Discount Rate. Therefore the acquiring bank then will either (1) collect amortized monthly principal and an agreed upon lowered interest payments from the individual or entity at a profitable spread of interest and payments to its own cash position as a receivable to recover the funds paid to the original bank or (2) allow the individual to enjoy a lower interest rate and incrementally pay/broker the amount received each month and direct some of these payments to its own books and to that of the original lender instead of paying the original lender in full lump-sum. This is when Banks lend from each other at the Federal Funds rate--which Banks themselves average and report at around .50% or 1 percent divided by 2 or 50 bases points (bps).

Once again in this time of Federal Budget Crisis of 2025 and cash shortages need to pay for Federal Salaries and programs refinancing of a Federal Reserve originated loan should not involve 100% Discount Rate funds. Corporations and Sole Props. must use their own cash in greater percentages to settle the original debt with the prior lender. This will free up paper derived from the Peanut shell.

I look forward to the July 22, 2025 telephone call. Please know that I mistakenly called Congressman Dan Goldman of New York before following up with the White House regarding this grant. To date he and other Representatives and Senators have not fulfilled this October 2020 \$4,000 Grant request.
