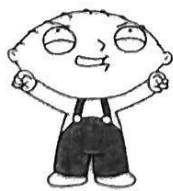

- Random Annihilation

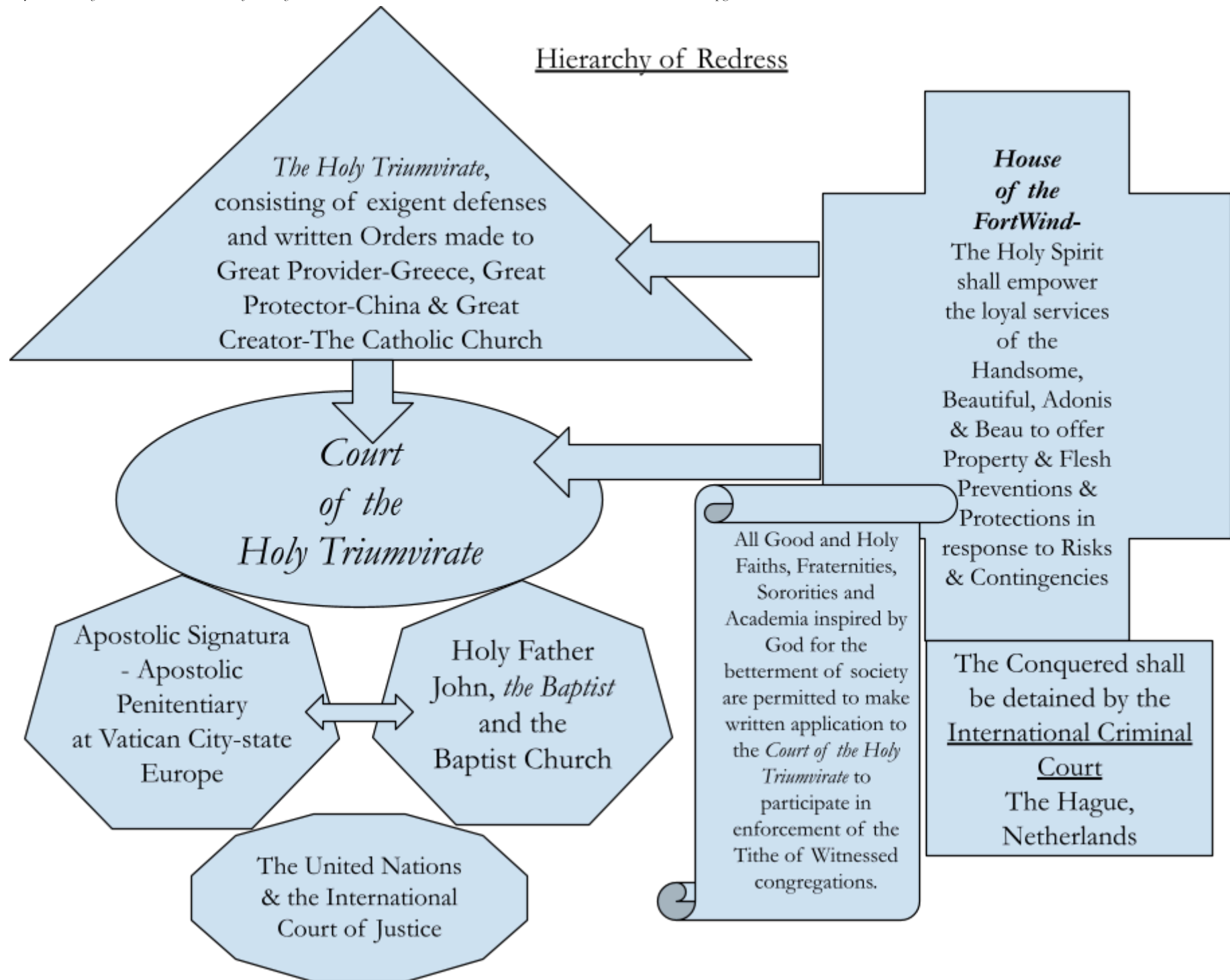

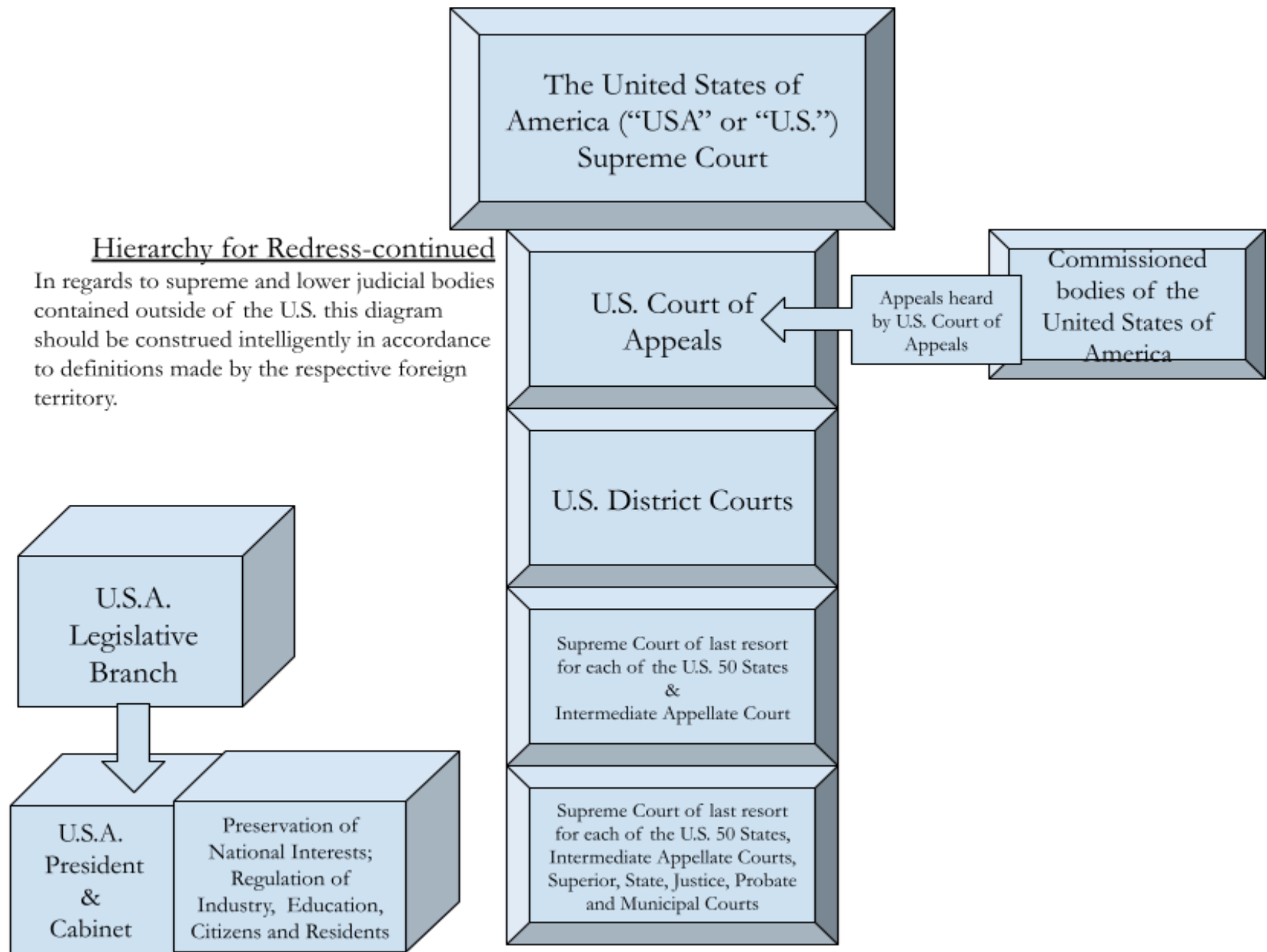
## **Ways of the *Court of the Holy Triumvirate***

I. *Ways of the Holy Triumvirate*

## (1) Scope of Power

(1.001) All lawful youth and citizens possessing age of majority who are prospective or aligned members of the *Holy Triumvirate* are permitted to display Constitutionally protected acts of self-defense, including verbal warning, mediation and Force.

(1.002) It is encouraged that males and females make written application for membership to the *Holy Triumvirate*. At the time of publication of these Ways only persons having citizenship from nations having reverence for an obedient living Demigod are permitted membership to the *Holy Triumvirate*. This is the Hellenic Republic of Greece, the People's Republic of China, The Catholic Church of Vatican City-State & international Archdioceses and the region that shall be known as Archdiocese America as was named by the Trust of 人81 Black Men of America and the Missionaries ("Trust").

Invitation for membership to the *Holy Triumvirate* was extended to the Great Rus of the Russian Orthodox Federation and the Hindu Nation of India.

(1.012) Homosexuals from any of Earth's Nations or who are derived from any realm of the Universes are automatic members of the *Holy Triumvirate* and shall serve concurrently.

(1.003) To cement this relationship, see Attachment A entitled *Agreements amongst the Holy Triumvirate* - Persons, Regions, Churches and Vessels, a Triumvir nation's highest executive leader shall affix his or her signature to contractually bind its nation (1) to further the trust's Article IV Section I provision containing the three beliefs of the Archdiocese of America and (2) to bring reform after receipt of Tithe or an agreed upon fee through (3) interventions as were enumerated in the founding resolution of the *Court of the Holy Triumvirate*, pages 1a to 12a of this file.

(1.004) Frequently persons, with reliance on the Canons<sup>3</sup> of the Catholic Church, the amicable Charter of United Nations<sup>4</sup> and associated bodies, Articles of the the Court of International Justice<sup>5</sup>, the United States of America's Federal Code<sup>6</sup>, appropriate State Codes and territories thereof, the federal and codes of Triumvir nations, who are aligned by approved contract with the *Holy Triumvirate* are permitted to generate **Orders** that shall contain two signatures— one of the author as well as that of the self-proclaimed Monk<sup>7</sup>-Emperor Mr. Jermaine Ezekiel. Spence.

(1.005) Therefore in offenses caused by persons, communities, states or nations whose premeditated belief and behavior it is to bring Intercepted, Disputatious or Offensively,

Unwarranted and Aggressive Force let there be equal and abundant exculpatory authorizations from these Ways, having a retroactive enactment to 10,000 B.C. or more.

(2) Commitments & Remittances

(2.001) The Archdiocese of America seeks that Triumvir member nations will abide by **Orders** to peacefully aid in the furtherance of Safe Liberty, Happiness, Family & Love and the golden fruits derived from Citizenship, Instruction and Laborious Efforts.

(2.002) The Archdiocese America asks that each Triumvir member remit the equivalent of \$100,000 in **Lifetime** lump-sum dues. At the time of publication this is ~~Dp~~30,944,367.20 Greek Drachmae all in the highest denomination; 元 715,344.29 Chinese Yuan offshore all in the lowest denomination; ₹9,212,500 Russian Ruble all in the highest denomination; the Indian Rupee ₹29,16,733.75 in the lowest denomination.

(3) Basis in 9

**Orders** of the *Holy Triumvirate* shall contain responses to 9 terms that are Comfort, Choice, Charity, Control, Counseling, Communication, Compromise, Truce and Comradery.

(4) Form and Particulars of Orders of the *Holy Triumvirate*

(4.001) All references to the *Holy Triumvirate* shall be italicized.

Each order shall display the Seal/Coat of Arms of the Archdiocese of America; Underneath the seal shall be the words “Before the *Holy Triumvirate*” and the author shall write his or her location to include a city and the name of the nation represented.  
(See Attachment B)

(4.002) The caption of any order presented for publication must always contain the names of all Triumvir nations, centered just beneath the Coat of arms. Next a style–prefaced by “In re” – shall be displayed with the names of the parties and a widely used or self-devised name of the conflict as well as the month and year that the order was composed.

A centered title shall appear in bold font, enlarged and underlined of no less than 20 point. A paragraph shall be entered below this title and provide historical background regarding the conflict.

A section labeled “Subjects & Targets” shall– with bullet points–lay forth all pertinent Persons, Documents, Goods, Regions, Churches and Vessels.

Nine paragraphs shall begin with the words Comfort, Choice, Charity, Control, Counseling, Communication, Compromise, Truce and Comradery; text adjacent to these 9 Aesthetics shall be Bold, underlined, minimum 15 point font and Single-spaced.

Finally a section containing “Orders” shall in sequentially numbered sentences direct the responses of the protagonist, antagonist, Arms, Goods and Vessels.

Clergy, Churchgoers and the Faithful associated with the *Holy Triumvirate* are encouraged to utilize running head in the header of each page and page numbers within the header or footer.

(5) Means of Transmission

(5.001) Transmission of the order shall consist of electronic mail (Email) dispatch to the Vatican city-state at [OBOLO@SPE.VA](mailto:OBOLO@SPE.VA) as well as to the email addresses of all known Archdioceses affiliated with the Catholic Church. Contemporaneous publication is to be made to all known email addresses of the governments of the Hellenic Republic of Greece ([www.presidency.gr](http://www.presidency.gr)), to the People's Republic of China (<http://english.www.gov.cn/>) the Russian Orthodox Federation (<http://en.letters.kremlin.ru/>) and to the Nation of India (<https://www.india.gov.in/>). It is advised that all parties involved receive the **Order** by Electronic and paper delivery.

(5.002) The email's subject line must contain the time of dispatch, noted from 0 to 2400 Hours; the date with an abbreviated month, numerical day and full year, be sequentially numbered and contain a shortened title.

(5.012) The Follow-up and Amendments

A periodic endeavor should be undertaken to gauge the effectiveness of the Forces of the *Holy Triumvirate* upon the conflict; orders following the initial order shall be numbered starting at .1, then .2, .3, .4, .5 and so forth.

(6) Publication

(6.001) Mr. Jermaine E. Spence or Webmaster shall publish the Order at <http://www.81Blackmen.org>, respecting Privacy, Confidentiality and Secrecy statutes and common-law guides.

(7) Recording

(7.001) After the **Order** is transmitted it is recommended for purposes of safekeeping that Clergy, Churchgoers and the Faithful make a Coordinated, Qualified or Notice filing with a Clerk of a competent judicial unit, regulatory department or agency or industrial body.

(7.002) Clergy, Churchgoers and the Faithful should store additional photocopies at His or Her personal residence and with a third party.

II. *House of the FortWind*

## (1) Creation and Reasons thereto

(1.001) Those chosen to live out the Mission and Vision of the Trust, to defeat intrusions to Aesthetics, to defend against False Witness<sup>8</sup> made against those who Tithe and those paupers who seek redress Mr. Spence hereby creates the *House of the FortWind*.

## (2) Required Credentials &amp; Stature

(2.001) Candidates for service to the *House of the FortWind* must (1) submit at least once to an examination of His or Her Intelligence Quotient; (2) be a High School Diploma recipient or General Educational Development with a printed Report Card of settled affairs. (3) Possess a Bachelor's degree. (4) Male or Female.

(2.002) (5) Men are required to be 6 feet 2 in height, of good health or be willing to make cosmetic changes.

(2.003) One's Race and Ethnicity/Culture and Community shall not be a factor for unfavorable regard as to acceptance to serve.

(2.004) Homosexuals upon Prayer to the Goodness of God are automatically accepted for service to *House of the FortWind*.

(2.005) Accession to any seat of the *Court of the Holy Triumvirate* requires (1) a Bachelor's degree in any science and a Paralegal degree, obtaining 18 months of studies or reflecting an Honorary award or (2) a Bachelor's degree and completed Graduate-level Master's degree or partial credits or (3) Professional degree such as a Ph.d., M.D. or Juris Doctorate.

## (3) Duties

(3.001) Sureties must acquire Arms and be aware of news media, conveying reports of conflict as often as is possible.

(3.002) Sureties should proudly retain documents such as photocopies of Birth Certificates, Bank Statements, personal effects, telephone contacts, proof of education, industrial tools, journal and Bible.

(3.003) Upon gaining servitude to the *House of the FortWind* Men and Women will, with fore-knowledge of agreed upon menaces, Prevent intrusions to and Protect against intrusions against the dealings of Mr. Jermaine E. Spence, subsequent commanders of the *Holy Triumvirate*, officials of the *Court of the Holy Triumvirate*, Mr. Spence's Family and network of employed and self-supported lawful colleagues.

## (4) Application &amp; Standard Contract

(4.001) An Application & Standard Contract shall be completed to gain service to *the House of the FortWind*. (See Attachment C)

(4.001) Investiture for Service to the *House of the FortWind*

Those Men and Women chosen for service to the *House of the FortWind* will receive written notification (See Attachment D) of such acceptance to serve and also be compelled to apply His or Her signature to this document to consecrate allegiance.

(4.011) Line and Sequence of Succession

Upon the Death of Mr. Spence one Man or Women will serve as sole Emperor of the Holy Triumvirate. Mr. Spence requires that this party also be a government member of either three of Triumvirs or of Russia or India. (Again, Homosexuals who attest to such identity are permitted to serve concurrently, displaying appropriate behavior and written **Orders** that, upon Mr. Spence's Death, do not require dual signature.)

(4.111) Investiture for Service as Emperor of the *Holy Triumvirate*

The Notice referenced in item II(4)(4.001) shall contain fields to appoint one Man or one Woman upon the helm of the *Holy Triumvirate*.

(4.211) Investiture for Service to the *Court of the Holy Triumvirate*

An unlimited number of Men and Women shall be permitted to preside over proceedings of the *Court of the Holy Triumvirate*. One Yay or Nay vote for or against the Plaintiff, Complainant or Appellant shall be made.

(4.221) No party with the exception of Mr. Spence shall be permitted to serve both offices of Emperor of the *Holy Triumvirate* and the *Court of the Holy Triumvirate*.

Therefore, servants to the *House of the FortWind*, upon gaining the required credential as is described in II(2)(2.005) will fill the seats of the Court upon annotation of the II(4)(4.001) Notice.

(4.311) Appointment as Executor of the Trust of 人 81 Black Men of America & The Missionaries is described in Article I(iii) of the Trust, *infra*.

(5) Compensation

Servants to the *House of the FortWind* shall receive a cheque per annum .25% of Mr. Spence's personal cash positions divided by the number of total servants. That is the decimal .0025 multiplied by the total balance of all personal cash balances divided by the total number of those in service to the *House of the FortWind*.



III. *Ways of the Court of the Holy Triumvirate*

## (1) Scope of Power

The Court is empowered to take action when the following are satisfied:

(1.001) There shall be no Statute of Limitations

(1.002) Litigant or the Accused demonstrated Lack of Liability or Inculpable Innocence

(1.003) Litigant demonstrated completion of all judicial avenues

(1.013) In consideration of the foregoing and associated costs the *Court of the Holy Triumvirate* request full payment of \$500 or written application and motion for waiver, demonstrating poverty. Particulars of poverty thresholds are subject to conditions of non-disclosure.

(1.023) The Court possesses Original, Direct Appeal & Appellate and Interlocutory Jurisdiction for Criminal and Civil matters involving Homosexuals.

(1.033) The *Court of the Holy Triumvirate* shall have Original Jurisdiction as the Court of Reform and Redress to address misdeeds of the United States of America Federal and State Legislatures and Executive branches by way of various Writs.

(1.043) The *Court of the Holy Triumvirate* shall have Appellate and Interlocutory Jurisdiction regarding the United States of America's Judicial branch by way of various Writs. (See Hierarchy of Redress, pgs 4 to 5, *supra*)

(1.043) The Court shall provide Humane aid to monitor Industry<sup>9</sup> and Disciplines<sup>10</sup>.

## (2) The Weighted Vote of Monk-Emperor Mr. Jermaine E. Spence

Although there shall be unlimited number of officials seated on the *Court of the Holy Triumvirate* Mr. Spence will hold 51% of the voting power. For example if there are 12 seated, then the decimal .51 multiplied times 12 yields 6.12 weighted votes.

## (3) Types of Directives, Opinions &amp; Judgements

(3.001) The Court will monitor the United States of America's Government and media in order to Compose Humane Declarative Directives, Redress Opinions and Judgements of Law and Equity.

(3.002) With enactment of these Ways and permission granted by Triumvir nations as is indicated The Court will intervene upon sua sponte motivations or by invitation.

## (4) Form of Pleadings

Pleadings shall be single spaced with font size no longer than 11. Pleadings must be in Standard American English.

(4.001) While gathering facts and evidence and in keeping with the Humane Science of Print Newspaper, Agent(s) before the Court should utilize Associated Press and the American Psychological Association stylebooks.

- (5) Method of Recommendations, Representation & Admission
- (5.001) Those Agents of the Court who do not possess a Juris Doctorate or similar tutelage must have the litigant as plaintiff or accused sign the brief above or beneath the signature of the agent.
- (5.002) The litigant/plaintiff, complainant, respondent or accused must be present at the time of oral argument(s) if the litigant/plaintiff, complainant, respondent or accused aided by those holding credentials as are described in II(2)(2.005)(1) and (2).
- (5.003) The Agent is permitted to make Recommendations to the litigant/plaintiff, complainant, respondent or accused before and during live court proceedings, and such Recommendations are then free to be reiterated verbally by the litigant/plaintiff, complainant, respondent or accused.
- (5.004) The Agent's direct examinations of the litigant/ plaintiff, complainant, respondent or accused is permitted in order (1) to introduce evidence<sup>11</sup> that arose after completing the trial-level pleading or to clarify within the record (2) typos, distorted images, et. cetera.
- (5.014) Cross examinations by the litigant/plaintiff, complainant, respondent or accused of the counter parry is permitted.
- (5.005) Agents and Attorneys must provide proof of credentials. There is no fee for admission. (See Attachment F)

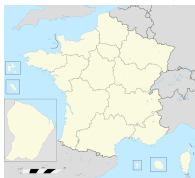

### Jurisdiction

The Catholic Church is empowered to take action as is requested in this letter/brief on these soils of the United States of America through the United Nations via (1) its anti-Ethnic Cleansing resolution and (2) the Genocide Convention.

- Item II.* I perceive that my nation the United States of America, state and native cities have refused legislative and military protections; know my Brothers and Sisters that you who are Virgin and Nun must provide a speedy and lasting solution to *[Property and Flesh]* attacks.
- Item III.* Your Holy and Faithful Beings will bring order to those who seek to bring to my existence Death by way of :
- Hedonism
  - Anarchy
  - Annihilation
- None of these subversive factions shall reap victory for the Homosexual Arsenal is Great Protector.*
1. *The Homosexual's Arsenal shall serve as careful yet speedy defense of the Trust and of the Catholic Church's interests.*
  2. *The Extrasensory, Clairvoyant and Telekinetic Homosexual Arsenal of Humane Wishes, Praises, Prayers, Tongues, Curses, Chanting and Humanistic Orders are gifts of our Lady God-the Holy Spirit.*

**Homosexual Purity/Homophobia**

Many, many ages ago I found *Comfort* in my *Choice* to be a Faithful Homosexual. This non-duplicity mindset allows me to devote myself to Gay Men of this world and many other causes of *Charity*. Like the seedless grape, the Homosexual is a sinless creature who, contrary to naysayers, can engage in civil unions, reproduce at will and have joint financial ventures.

**Ethnic Cleansing**

Thereafter my property and education became threatened due to my Homosexuality for the second occasion when in the Summer of 1999 my high school guidance counselor misspelled my name on the Honor's Graduate diploma. Upon my advisement of this she re-ordered the document but refused to indicate the dual seal for the College Preparatory and Technical/Vocational tracks.

After living in Atlanta for more than nearly five years a clan of two--one male and one female--rammed my parked car on June 1, 2007 the day that I incorporated Spence-Lingo.

By that time the Atlanta Police Department had refused me police services.

Indeed instead of charging the June 1 driver with Criminal Damage to Property the officer did nothing. In November 2007 an APD officer forced my admission to an Atlanta hospital to cause undue embarrassment and to prevent my future entry into politics.

Additionally it is my belief that military layman David H. Petraeus had three credit cards and one bank account linked debit card to fail on December 24, 2007. Afterwards I took to a multi-state road trip, returning to Georgia in the Spring of 2008 when I witnessed at around 1 A.M. a green, iridescent school bus west of Albany mostly likely filed with the Klu Klux Klan. I made application to the Federal Bureau of Investigation only to see the website collapse upon its submission.

It was the Hapeville Police Department (HPD) between January 2014 and May 2014 who refused to provide to me police services. The HPD brought harassment and encountered my 12 instances from January 2014 to May 2014.

### **Genocide**

As a youngster I had 7 or so frightening dreams<sup>7</sup> that were a foretelling of events of the past and future. One event it is my belief that as an infant a family member--upon the insistence of two women located in Boston--had me ingest a deadly tapeworm that eventually voided with diet and Prayer.

And too as a youngster a neighbor, in response to a telephone call from U.S. Department of Defense layman Colin Powell, struck me with a stone, causing a bloody injury to my head.

While detained in the Fulton County Jail at 901 Rice Street--before I requested Protective Custody--inmate and military layman J. Salters punched me in July/August of 2010 and jail and Dept. of Defense layman Charles Sheppard severely beat me on December 25, 2010.

All these attempts at murder are examples of Homosexual Genocide.

I look forward to becoming an empowered member of the Catholic Church such that the aforementioned property and flesh intrusions do not go without response by my own hands. This brief is being transmitted to bring a separate criminal and civil case to the Vatican's judiciary against four laymen of the US. Department of Defense and the department itself.
